BID CONTRACT REQUIREMENTS

It is the intent of this document to describe in sufficient detail a 3/4 ton (short wheel base, double cab) 4x4 truck specifications for which are noted herein, to be equipped and configured as shown on manufacturer's current specification sheet, unless otherwise stated.

BIDDER SHALL RESPOND IN WRITING UNDER "FURNISHED COLUMN" TO ALL NUMBERED ITEMS LISTED IN THE SPECIFICATIONS. A check mark or "Yes" is sufficient if the item bid is identical to what is requested by specifications. Bidder shall provide details on items bid that differ from what is requested by specifications. **Bid will be incomplete and rejected if the FURNISHED COLUMN is not filled in. Bidder must meet all minimum specification requirements to be considered for Award of Bid.** Bidder may exceed specification requirements unless a maximum is specifically stated in this document.

All parts which are not specifically mentioned but which are necessary to provide a complete vehicle shall be included in the bid and shall conform in strength and quality to that which is provided in the trade in general. Any standard manufacturer's features on the item(s) bid which are not listed specifically in this document are to be provided as a part of the bid. Features specified which are not available as a manufacturer's option shall be considered as preferred items whenever these do not affect the life, safety, operational cost, or performance of the item bid.

Vehicle is to be of current design, under current production, and in new condition with all manufacturer's warranties in full effect. No used vehicles, prototypes or experimental models will be accepted. Serial number on equipment or Manufacturer's Statement of Origin shall indicate year and month built. Bidder is required to furnish manufacturer's authorized parts and service for the vehicle bid at a location convenient to District facilities.

The total dollars quoted by the bidder on the bid tabulation sheet (item 23) of this document shall constitute the guaranteed maximum cost to the West Central Texas Municipal Water District for the completion of all specification requirements. The West Central Texas Municipal Water District shall not be liable for any additional or subsequent costs directly related to this bid agreement after Award of Bid.

Performance is a consideration in Award of bid. A list of current users is to be furnished upon request by the West Central Texas Municipal Water District. Names, contacts, addresses, and phone numbers of governmental and private agencies in receipt of the model bid are to be included in the list. Performance tests may be required at District's election prior to Award of Bid.

The West Central Texas Municipal Water District reserves the right to reject any and all bids and to waive any and all formalities and technicalities. The West Central Texas Municipal Water District also reserves the right to retain or trade-in any applicable equipment in part or in whole. All trade-ins are on an "as is" basis with no warranties. Bidder shall assume all risks and liability of ownership and possession of any unit traded-in under this bid agreement. Bid shall be considered valid for a period not to exceed 60 days from the opening of the bids.

Under no circumstances will the West Central Texas Municipal Water District accept a unit which exceeds legal weight limits or which is in violation of any Federal, State of Texas, or local law. Unit bid, when fully loaded in all standard on and off road operations, is to be in full compliance with all applicable Environmental Protection Agency (EPA), Occupational Safety, and Health Administration (OSHA), and National Institute of Occupational Safety and Health (NIOSH) regulations. All items bid must meet all applicable American National Standards Institute (ANSI) requirements.

The West Central Texas Municipal Water District is exempt from Federal Excise Tax, Federal Transportation Tax and State Sales Tax.

Any deviations or exceptions to specifications shall be requested in writing by the bidder. If such deviations or exceptions are acceptable to the District, an addendum to the specifications shall be issued.

The unit is to be fully assembled and ready for service at delivery. Delivery of an incomplete unit or of a unit not in compliance with the specification requirements listed in this document will not be accepted by the West Central Texas Municipal Water District, nor shall any payment be made during the period that the total delivery is not in compliance.

A copy of this completed and signed specification document is to be submitted to the West Central Texas Municipal Water District as the bid form for this item. A printed brochure is also to be furnished at bid opening, depicting the vehicle and accessories bid and describing their capabilities.
